NAME OF THE TRUST

1.That the name of the Trust shall be "AMAR SAATH FOUNDATION" herein after called the Trust, formed and operated under the provisions of law as applicable to the Public Charitable Trust. - 6. To the widows who do not earn and have nobody else to support them.
